The article is very important and describes precisely the ocular extraintestinal manifestations of IBD, but it should be shortened significantly to make it more readable for the needs of the journal. It is especially desirable that parts describing the ophthalmic manifestations be shortened if possible, taking into account that the readers of the journal are mostly gastroenterologists. Introduction Paragraph 1, Line 3. Please use different pathophysiology instead of differing pathophysiologies. Paragraph 3. "IBD has no cure". This expression is not correct. It is better to say: "IBD is a chronic disease and requires chronic treatment... etc". Extraintestinal manifestations The statement that extraintestinal manifestations seem to be related to the antigen - antibody complex is an oversimplification. More complex mechanisms are speculated in some cases. Please correct the statement. Page 5, line 19. Please correct: "More frequent in women" Page 6, line 9. "symptoms were neither specific, nor..." Page 11. Please replace "disabsorbing syndromes" by "malabsorption syndromes".

In this review article, the authors report on inflammatory bowel disease being complicated by ophthalmic involvement. This is a broad based report with clinically relevant information in IBD setting and beyond. Therefore, I have only favourable comments for the authors. I believe that the impact of your manuscript will significantly benefit from minor language editing throughout. For example, under: Other ophthalmic manifestations' the text says: "Some of them can be devastating if not immediately recognized and treated". It could read better as: Some of these manifestations can be debilitating if not recognized and treated at an early stage. Similarly, in the Abstract, line 6 from the end, the text says "in active IBD, and primarily in the presence of others EIMs". Could read better as: in active IBD, mainly in the presence of other EIMs.
