<b>Introduction</b>	<b>4</b>	Brief background summary of this case referencing the relevant medical literature	3/19
<b>Patient Information</b>	<b>5a</b>	Demographic information (such as age, gender, ethnicity, occupation)	4/19
	<b>5b</b>	Main symptoms of the patient (his or her chief complaints)	4/19
	<b>5c</b>	Medical, family, and psychosocial history including co-morbidities, and relevant genetic information	4/19
	<b>5d</b>	Relevant past interventions and their outcomes	4/19
<b>Clinical Findings</b>	<b>6</b>	Describe the relevant physical examination (PE) findings	5/19
<b>Timeline</b>	<b>7</b>	Depict important milestones related to your diagnoses and interventions (table or figure)	5/19
<b>Diagnostic Assessment</b>	<b>8a</b>	Diagnostic methods (such as PE, laboratory testing, imaging, questionnaires)	5/19
