the femoral artery using VCDs over a 17 month period". Here, the authors should clearly say to report the experience of closing the femoral artery puncture site during diagnostic and interventional angiographic procedures. Also in this part, what does MC stands for? Please give the full phrase. If it is used only once or twice, please use just the full phrase. 2. INTRODUCTION: At the end of this part, the authors should introduce briefly the use of other similar VCDs in the market, reports of use of VCDs in the literature, and problems existed in the use of this kind of devices before he turned to the purpose of this study. 3. In the "Patients and procedures" section, what does this sentence mean "A total of 172, 5 Fr ExoSeals were used in 118 patients?" A total of 172 what? 4. References: In this part, the latest reference used was from 2015. Are there any other new references from 2015 to 2018 not cited in the article? Please check. 5. Figures: The legends for these figures are too simple and cannot be properly understood by the reader. Please add some more explanation to the figures. 6. The results of this study is not novel because some studies with a large sample have been published while the authors did not cite as follows: 1).
