not clear. No figures of the immunohistochemistry of the tissue are shown. No current concepts about molecular analysis are described. My main concern is that no new findings are described in the study. It is necessary to perform more molecular studies in the tumor (i.e PD-L1, CD3 + CD8 +, etc.), to enrich what is known in the literature.
