**Spontaneous intrahepatic portosystemic shunt** (SIPSVS) is defined as a communication between the **portal** and systemic venous circulation, and is at least partially located inside the liver. Unlike dilated **paraumbilical veins** caused by **portal hypertension**, SIPSVS is generally considered **rare**, even though advanced imaging modalities have successfully revealed these abnormalities.
