written quite well. Minor revision is required. Reviewer believes that the amended article has a chance to find many readers. (3) Format: Eight tables and one figure. Sixty-two references were cited, including eight references published in the last three years. One self-citing article. 2 Language evaluation: A. Language editing certificate was provided by Charlesworth Author Services. 3 Academic norms and rules: The authors provided biostatistics review certificate, clinical trial registration statement and CONSORT 2010 statement. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was provided. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by High-level university research project in Guangzhou University of Chinese Medicine; Guangdong Provincial Department of Finance; Guangdong Provincial Department of Science and Technology; Guangdong Bureau of Traditional Chinese Medicine; Gangzhou University of Chinese Medicine planning; and Special funds for the construction of national and regional TCM in diagnosis and treatment centers (Letter of the state administration of traditional Chinese medicine. **Editorial Office Director:** Recommend for potential acceptance to the WJG. 1. Scientific quality: I have checked the comments

written by the science editor, and I basically agree with the science editor. The topic of the paper is the Yikou-Sizi powder hot compress on Shenque acupuncture point combined with rapid rehabilitation technique, and is within the scope of the WJG. Reviewer 00057659 stated that this prospective, multicentre, randomised and control study, comparing the controlled group with Traditional Chinese Medicine as a quite interesting. However, the questions raised by the reviewers should be answered. 2. Language quality: 1A. Language certificate was provided by the Charlesworth. 3. Academic norms and rules: I have checked the documents, including the conflict-of-interest disclosure form, copyright license agreement, biostatistics review certificate, clinical trial registration statement, CONSORT 2010 statement, institutional review board approval and the informed consent statement, all of which are qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by 6 Research Foundation. The authors don't provide the grant application form(s). (3) Corresponding author has not published articles in BPG journals.
