Timeline	5	Information from this case report organized into a timeline (table or figure)	<u>4</u>
Patient Information	6a	De-identified demographic and other patient or client specific information	<u>4</u>
	6b	Chief complaint—what prompted this visit?	<u>5</u>

Physical Exam	7	Relevant physical examination findings	<u>5-6</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>6</u>

	8c	Consider tables or figures linking assessment, diagnoses and interventions	<u>12-16</u>

Interventions	9a	Types such as life-style recommendations, treatments, medications, surgery	<u>5-6</u>
