The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: It is a well-written paper from all the aspects, may be some English language editing. The reviewer suggests authors to compare their technique with the standard of care procedure. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total</p>	[ ]

of 14 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Peerwith was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE checklist form, and written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; Foundation of Sichuan Educational Committee; Foundation of Sichuan Health Committee; Nanchong Government and North Sichuan Medical College Cooperation Project; and Foundation of North Sichuan Medical College. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the

Please revise throughout; (5) I found the "Case Presentation" did not meet our requirements.
