2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the pancreatic panniculitis and elevated serum lipase in metastasized acinar cell carcinoma of the pancreas. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In this manuscript, the</p>	[Y]

authors reported a case with pancreatic acinar cell carcinoma that had serum lipase elevation. The authors insisted that the serum lipase level correlates with the clinical symptoms and progression of pancreatic acinar cell carcinoma. Acinar cell carcinoma of the pancreas is a rare condition, and there are only a few reports that mention the correlations between serum lipase and disease progression. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 5 figures. A total of 48 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. Written consent to surgery, pathology and follow- up was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) Please provide the written consent to surgery, pathology and follow- up; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
