	<p>#00608250 point out that Authors talks about early abdominal complications after cardiopulmonary by-pass, but they do not specify to which kind of complication they refer, and Authors do not show data about clinical characteristics at baseline (before cardiac surgery), so it cannot exclude that those patients with abdominal complications had already a worse clinical situation; #02511796 point out that this study lacks details in many areas.
