2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the ADHD and GI comorbidity. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer#05117318 thinks this is a well written paper. It covers an area where there is very little published data and the findings are clinically relevant. Particular strengths of this study include the large cohort and</p>	[ Y]

robust statistical methods. The authors have addressed the limitations in the discussion. However, there are some points need to be addressed. The reviewer suggests the authors comment on whether psychiatric co-morbidities are highly prevalent in their cohort of patients. The authors should discuss the FGIDs. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 33 references are cited, including 2 references published in the last 3 years. The authors need to update the references. There are no self-citations.

2 Language evaluation: Classification: Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1993 (under 45 years old). The corresponding author is the member of The Israeli Society of Gastroenterology and Liver Disease. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and

	<p>arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) The authors need to fill out the STROBE checklist with page numbers. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
