**Editorial Office Director:** Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of "Hypotension after anesthesia-to-ICU drop-off in cardiac surgery patients" is in the scope of WJCCM. Reviewer#03093768 pointed out that hypotension after cardiac surgery is common, especially during transport from the operating room to the ICU, and carries certain risks. The clinical analysis of hypotension during transport in this article is of guiding significance in clinical practice. However, there are some points need to be addressed in the manuscript. Such as: The title indicates that adult heart surgery may be more appropriate; The purpose of the paper is not stated in the abstract; Does the case in this article take into account the different hypotension caused by different surgeons or different anesthesiologists? And so on. The authors need to revise the manuscript according the reviewer's comments. There are 3 figures and 5 tables in the manuscript. Twenty-five references were cited,

	<p>without references published in the last three years. The authors need to update the references. One self-citation. 2 Language evaluation: I agree with the comments written by the science editor. The authors are from United States. 3 Academic norms and rules: I have checked the documents including the conflict-of-interest disclosure form, copyright license agreement, biostatistics review certificate, and institutional review board approval file, which are qualified. The authors stated this research is a retrospective study. Patients were not required to provide informed consent for this study because the analysis used anonymous clinical data that were obtained after patient had agreed to treatment with written consent. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG. (4) The authors need to provide an editable manuscript of Word format.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with minor revisions.</p>
