(1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The topic might be of interest for clinical practice. This is a very informative, well written and concise manuscript. However, there are some issues should be addressed. Please make the topic clear and the contents well organized. In the section of "Discussion", please discuss the difference between</p>	[Y]

results of your research and previous studies. Stronger evidence may be needed for the conclusion of “ALBI grade performs better than CTP score”. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 212 references are cited, including 124 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript (UEG Week Barcelona 2019). The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no “Author contribution” section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (5) I have

	<p>changed the manuscript type “review” to “systematic review”. The authors need to revise the manuscript according to the Guidelines and Requirements for systematic review and provide the Biostatistics Review Certificate and fill out the PRISMA checklist form with page numbers; and (6) the author should number the references in Arabic numerals according to the citation order in the text.
