should also provide some background for the doses of AICI3 they selected to study; and (3) Format: There are 4 figures. A total of 39 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. The language editing certificate was not provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form and the ARRIVE Guidelines are not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 4 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The language classification is Grade C.
