The topic is in the scope of WJCC. (1) Classification: B and C. (2) Summary of the peer-review report: An interesting study. The aim of the study is clear, and the methods are good. Data in tables are very interesting. A minor editing is required for tables. Reviewer recommend to accept the manuscript</p>	[Y]

after a minor revision. The manuscript is well written. (3) Format: Four tables and three figures. Twenty-nine references were cited, including ten references published in the last three years. No self-citation. 2 Language evaluation: 2B. Language editing certificate was provided by EssayStar. 3 Academic norms and rules: The authors provided biostatistics review certificate and STROBE statement. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was provided. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by Medical and Health Foundation project of Zhejiang Province, China and Natural Science Foundation of Zhejiang Province, China. (3) Corresponding author has not published articles in WJCC.

**Editorial Office Director:** Recommend for potential acceptance to WJCC. 1. Scientific quality: B, C. The topic of this manuscript is an observational study of RT3DE predicting chemotherapy induced cardiotoxicity, and it is within the scope of WJCC. The reviewer 02856921 thought the manuscript was well written, and it was an interesting study of RT3DE in breast cancer. The reviewer 01507457 thought that this study analyzed the value of RT3DE-related indicators for early prediction of cardiac toxicity caused by chemotherapy among breast cancer patients. Some minor revision was required for tables. There are 3 figures and 4 tables in the main
