	method section, there are some subjective and inappropriate comments. Case reports section is too long and there are many unnecessary and non-surgical details. They should short this section, and make it simply to understand. 3 figures and 1 table, 14 references were cited, including 1 latest references from 2017-2020. No self-citation, we suggest the authors to cite their own research results. 2. Language quality: A. Edited by the MedCom Asia, Inc. 3. Academic norms and rules: Copyright license agreement, Conflict-of-interest, Informed consent statement, and CARE Checklist are correct. Google search and CrossCheck are eligible. 4. Others: Without financial support. Corresponding author has not published articles in WJCC. Unsolicited manuscript.
