Bing search and CrossCheck are eligible. 4 Others: With National Natural Science Foundation of China financial support. Corresponding author has not published articles in WJP. Invited manuscript.</p> <p>Editorial Office Director: Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of epilepsy is in the scope of WJP. Reviewer 03887097 showed that this is a competent study with some useful findings, but there are some following comments for the authors to contemplate. The questions raised by the reviewer should be answered. There are 5 figures in the manuscript. Forty-five references were cited, including fourteen references published in the last three years. No self-citation. 2 Language evaluation: I agree with the comments written by the science editor. There is no any Language editing certificate. 3 Academic norms and rules: I have checked the documents including the copyright license agreement, biostatistics review certificate, and The ARRIVE Guidelines, which are qualified.
