The topic is in the scope of WJG. (1) Classification: 2B and C. (2) Summary of the peer-review report: This study is very interesting. The manuscript is very well written. The tables are very good, minor editing are required. The study is very designed. Reviewer recommend to accept the</p>	[ Y ]

manuscript after a minor language editing. (3) Format: Three tables and two figures. Thirty-one references were cited, including fifteen references published in the last three years. No self-citation. 2 Language evaluation: 3B. Language editing certificate was provided by MedE Editing Service. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The author declare that the study was approved by Beijing hospital ethics committee to be exempted from ethical review. The author declare that all private data and information of the patients have been concealed. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJG.

**Editorial Office Director:** Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of colorectal cancer is in the scope of WJG. Reviewer#02846004 summarized that the authors investigated the composition and factors related to inpatient medical expenditure in colorectal cancer patients based on disease diagnosis related groups, and provide a basis for the rational economic control of hospitalization expenses for the diagnosis and treatment of colorectal cancer. Overall, the manuscript is very well written. Reviewer# 03250867 pointed out

that the study is very designed and written. But the language needs a minor polishing. Reviewer#02945967 thinks this is an interesting study of DRGs grouping of inpatient medical expenditure in colorectal cancer patients, the authors attempted to determine the main influencing factors related to inpatient medical expenditure in patients with colorectal cancer, to help medical institutions standardize the clinical diagnosis and treatment process in order to control medical cost. Manuscript is well written, but a minor language editing is required. There are 2 figures and 3 tables in the manuscript. Thirty-one references were cited, including fifteen references published in the last three years. No self-citation. 2 Language evaluation: Although the authors provided Language editing certificate of MedE Editing Service, the language needs to be further improved. 3 Academic norms and rules: I have checked the documents including the conflict-of-interest disclosure form, copyright license agreement, and biostatistics review certificate, which are qualified. This research is a retrospective study. Patients were not required to provide informed consent for this study because the analysis used anonymous clinical data that were obtained after patient had agreed to treatment with written consent. The authors need to provide the IRB file. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support.
