Edited by authors. Authors did not provide English editing certificate by company. 3. Academic norms and rules: Opinion review. Conflict-of-Interest statement is complete and qualified. The format of the Copyright license agreement is not correct. The authors have signed their signature. Bing search is eligible. CrossCheck: the similarity index is too high, which doesn't meet the publishing requirements. 4. Others: Without financial support. Corresponding author has not published articles in WJG. Invited manuscript.</p> <p>Editorial Office Director: Recommend for potential acceptance to WJCC or WJCO. 1. Scientific quality: 2B, C and D. The topic of this manuscript is an opinion review of laser ablation in neuroendocrine neoplasms. The reviewer 03270441 thought that authors cannot draw their conclusions due to the limited literature provided in this manuscript. And the authors need to make major revision in structure and language. In addition, some tables or figures need to be added. 2. Language quality: A, 3B. The authors have provided the file "Non-Native Speakers of English Editing Certificate". And this paper has edited by the corresponding author. 3. Academic norms and rules: "Conflict-of-Interest Disclosure Form", and "Copyright License Agreement" files are complete and qualified.
