A language editing certificate by AJE was provided. 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form and Copyright License Agreement were provided. Signed Informed Consent Form(s) or Document(s) was not provided and CARE checklist (2016) were uploaded. No academic misconduct was found in the Bing search and the similar index is 43% in the CrossCheck detection, the repeated sentences should be rephrased. 4 Supplementary comments: This is an unsolicited manuscript. Supported by the Natural Science Foundation of Zhejiang Province (LY19H290003), Zhejiang Provincial Medical and Health Science and Technology Project (2020KY196), Foundation of Zhejiang Province Chinese Medicine Science and Technology Plans (2017ZB030), and Key Project of the 2017 School Research Fund of Zhejiang Chinese Medical University (2017ZZ02). The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. And please provide the Table 1 as a three wire table but not a figure. (2) Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. (3) Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND</p>
