While the manifestation itself is interesting, the authors fail to adequately describe it in the manuscript. Specifically, some additions that could help the readers better understand. 	<p>details in the “method” section. Generally, the authors description of the patient’s hospitalization is very brief and wooden. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 9 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by MedE was provided. The language needs to be further improved. 3 Academic norms and rules: The authors provided Conflict-of-Interest Disclosure Form and the written informed consent. The authors need to provide the Copyright License Agreement signed by all authors and fill out the CARE checklist form with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 7%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
