Reviewer proposed this manuscript has lots of grammar and punctuation amendments. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. The written informed consent and CARE Checklist were uploaded. No academic misconduct was found in the Bing search. The highest single-source similarity index of CrossCheck is 6%, and it is unqualified. 4 Supplementary comments: (1) Unsolicited manuscript.
