The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The reviewer#03648840 thinks the abstract and conclusion section needs to be revised to be more informative. very brief and needs to be improved by adding more studies and the discussion section needs to be summarized. (3) Format: There are 3 figures and 4 tables. A total of 20 references are cited, including 8 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form, the Institutional Review Board Approval Document, the Biostatistics Review Certificate and the STROBE Statement. The authors signed the Copyright License Agreement and the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list. Please revise throughout. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance. (Han Zhang)
