The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The manuscript is well written and of interest for the readership of the</p>	[Y]

journal. The A, B, and C of Figure 1 are suggested to be put together to make a large diagram, with the notes at the bottom of the diagram. A and B in Figure 2 are the same as above; author should add a comment on the abbreviation below Table 1, such as “CBS: Carotid blowout syndrome; CCRT: Concurrent chemoradiotherapy”; and (3) Format: There is 1 table and 2 figures. A total of 15 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by CACTUS was provided. 3 Academic norms and rules: The authors provided the -CARE Checklist-2016. Please provide the informed consent document again. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) Please provide the PDF version of the Copyright License Agreement Form that has been signed by all authors; (4) Please provide the PDF version of the
