report: Reviewer#03478442 thought this is a well written manuscript including presentation of hepatobiliary manifestations in children with inflammatory bowel disease in the authors' center and a concise review of the literature on the subject. The findings are not surprising but more or less expected by the available literature on the subject, however the authors present their own experience honestly and with enough details and information provided. Suggestions. There are some minor language or typing errors which should be corrected with a careful inspection of the manuscript. The last part describing the research methods and conclusions should be incorporated into the text to have the standard format of manuscripts. Reviewer#02451447 thought the sample size is too small and recommend the authors to expand to 3 years' data and resubmit. Reviewer#03478404 thought there were many questions, the authors must amend. Reviewer#00503587 thought this was a potentially important and interesting study, but work needed to shorten. (3) Format: 4 tables and 3 figures. 39 references were cited, including 14 references published in the last 3 years. No self-citation. 2 Language evaluation: B and 3C. Language editing certificate was provided by SNAS. 3 Academic norms and rules: The biostatistics review certificate was provided. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was not properly provided. The written informed consent was uploaded. The STROBE statement was uploaded. No

(3) The corresponding author has published 9 articles in BPG journals.(Xiao-Quan Yu)</p> <p>Editorial Office Director: 1 Scientific quality: This manuscript describes an observational study of hepatobiliary manifestations in children with inflammatory bowel disease, and it does not reach the publication standard of the WJG. (1) Classification: Grade B, Grade C, Grade D, and Grade E; (2) Summary of the Peer-Review Report: Reviewer 03478404 thought that the paper had many limitations and its scientific quality was low. The English language required major revision. Reviewer 02451447 thought that the sample size was too small, and recommended the authors to expand to 3 years' data and resubmitted. And (3) Format: There are 4 tables and 3 figures. A total of 39 references are cited. There are no self-citations. 2 Language quality: Classification: Grade B, Grade C, Grade C, and Grade C.
