The reviewer#02948419 recommends extending the section "Therapeutic options: clinical applications of microRNA" and authors could get more information regarding target audience, in which novel approach may be useful and reflect on considerations why this approach might be better than currently implemented. (3) Format: 4 figures and 1 table. 240 references were cited, including 62 references published in the last three years. No self-citation. 2 Language evaluation: 2A and B. The author is a native speaker of English. 3 Academic norms and rules: The authors did not provide the conflict-of-interest disclosure form. The authors signed the copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by Heart Research UK. **Editorial Office Director:** 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is the atherosclerosis, and is within the scope of the WJC. (1) Classification: Grade C, Grade A, and Grade D; (2) Summary of the Peer-Review Report: Reviewer#03846820 thinks this article is written with the good English-speaking adduction of the arguments. The article is sufficiently novel and very interesting to warrant publication. All

the key elements are presented and described clearly. The authors need to correct all the rare typos and grammar errors throughout the manuscript, and suggest emphasizing the novelty of the paper within the topic you have analyzed. Reviewer#02948419 pointed out this is excellent paper that is well organized, excellent written and opens out current position and future perspectives in epigenetic transformation in modification of macrophages and shaping of foam cells. Reviewer recommend the authors to extend that section "Therapeutic options: clinical applications of microRNA". Authors could get more information regarding target audience, in which novel approach may be useful and reflect on considerations why this approach might be better than currently implemented. Reviewer# 03722832 suggest the authors to update the references; and (3) Format: There are 4 figures and 1 table. A total of 240 references are cited, including 62 references published in the last 3 years. There are no self-citations. We suggest the authors to cite some their own research works. 2 Language evaluation: This manuscript is from United Kingdom. The reviewer thinks the language need a little of polishing. 3 Academic norms and rules: I have checked the documents, Copyright License Agreement is qualified. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Heart Research UK.
