The questions raised by the reviewers should be answered; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by the science editor. A language editing certificate issued by Spandidos Publications was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, and the Informed Consent Statement, all of which are qualified. No academic misconduct was found in the

Please write the “core tip” section behind of the key words. (4) I found that the “case report” section is not written according to the guideline of the journal. Please re-write the case report section (Case Presentation), and add FINAL DIAGNOSIS, TREATMENT, and OUTCOME AND FOLLOW-UP section to the main text accordingly. (5) I found the PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout; (6) I found that the figures can’t be edited. Please provide the original figure documents. All submitted figures, including the text contained within the figures, must be editable. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; 6
