2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the Rno_circ_0005139 plays a role in rat anorectal malformations. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Reviewer#02453616 thinks this manuscript has good quality, but there are some points need to be addressed. The authors investigated differential expression of circRNA and mRNA expression in their ARM animal model and identified 38</p>	[Y]

upregulated and 42 down-regulated circRNA. The authors need to explain the reason why that they choose the circRNA 5139, but not 436 and 9285. These two seem to be interesting as their differential expressions also have statistical significance. Secondly, why was Wnt5a chosen? The authors need to clarify these two questions; and (3) Format: There are 1 table and 5 figures. A total of 25 references are cited, including 4 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and Institutional Review Board Approval Form. The authors need to provide Institutional Animal Care and Use Committee Form. The authors need to add the page numbers in the ARRIVE file. No academic misconduct was found in the Bing search. CrossCheck detection is a little high, our editorial policy states the overall similarity should be less than 30%, the overlapped section should be less than 5% in single papers, including author's own work. The authors need to rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please
