thinks the article is informative but objectives need to be clarified as primary and secondary. Elaborate on sample size and discussion needs to be focused. The reviewer #00503175 thinks the manuscript is adequately written. (3) Format: There are 3 tables and 1 figure. A total of 16 references are cited, including 2 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by CACTUS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors signed the Copyright License Agreement and the Conflict-of-Interest Disclosure Form. The authors did not provide the Signed Informed Consent Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the grant from National Key R&D Program of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance. (Han Zhang)
