(1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: Reviewer#05261050 thinks this is an interesting study of the prognostic significance of KIF23 expression in gastric cancer. This study is well designed, and the results are very interesting. Reviewer# 05261051 thinks the design of the study is good. Methods are very clear, and in detail. Results are very</p>	[Y]

interesting. However, the figures are too small. Images should be updated. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 28 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the ARRIVE form. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high (total 30%). According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Shenyang High-level Innovation Talents Plan. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the WJG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents.
