The reviewer# 03072151 suggests the authors should discuss further about the association of the immunosuppressed condition with EA and insert suitable references. The reviewer#02916651 thinks the authors should mention the relationship between the EA and HIV. And is there any optimal option suggestion of the sequence for treatment? (3) Format: There are 2 figures. A total of 21 references are cited, including 6 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B, Grade B, Grade B and Grade B. The author is a native speaker of English. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. (3) Please add the "CASE PRESENTATION", "FINAL DIAGNOSIS", and "OUTCOME AND FOLLOW-UP" sections to the main text according to the Guidelines and Requirements for Manuscript
