2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: Recommend for potential acceptance. 1 Scientific quality: The manuscript is a retrospective study of MLR in blood samples of CRC patients. The topic is in the scope of WJG. (1) Classification: 2C and D. (2) Summary of the peer-review report: Generally, the study has some medical significance. The assays were reasonably designed to some extent, and based on the present</p>	[Y]

design, the results were well presented. However, some essential information are lacking in the manuscript which deduced the quality of the manuscript. The sample size is not quite big. The title/subject is very interesting and topical, the manuscript is well structured and well written. Numbers and letters on all Figures 1 and Figures 2 are too small. (3) Format: Four tables and four figures. Sixty-two references were cited, including thirteen references published in the last three years. No self-citation. 2 Language evaluation: A and 2B. Language editing certificate was provided by a native English speaker. 3 Academic norms and rules: The format of the conflict-of-interest disclosure form and copyright license agreement is not correct. The institutional review board approval form was uploaded. The written informed consent was waived. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJG.
