the thickness of quadriceps muscle before and after ICU stay by ultrasonography. It is a nice and well conducted study which merits publication after revision. The study needs good English editing. 2 tables and 6 figures. 29 references were cited, including 9 latest references from 2017-2020. 2 self-citation articles. 2 Language quality: A,B. Language certification is not qualified. 3 Academic norms and rules: Observational Study. Copyright license agreement, BRC and Conflict-of-Interest statement files are complete and qualified. Signed informed consent and IRB files are not qualified. Bing search and CrossCheck are eligible. 4 Others: Without financial support. Corresponding author has not published articles in WJC. Invited manuscript.

Editorial Office Director: Recommend for potential acceptance to the WJC. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of this manuscript is an observational study of cardiothoracic surgery, and it is within the scope of the WJC. The reviewer 00225357 stated that this manuscript is a nice and well conducted study. The reviewer 00225357 pointed out that the study is interesting but he has few comments. The questions raised by the reviewers should be answered. 2. Language quality: 1A1B. The authors have not provided the language certificate. 3. Academic norms and rules: I have checked the documents, including the conflict-of-interest disclosure form, copyright license agreement, biostatistics review certificate, and the informed consent statement,

	<p>all of which are qualified. The institutional review board approval is not qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) The corresponding author has published 4 articles in BPG journals.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision.
