2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript is a review of energy metabolism in the cancer stem cells. The topic is in the scope of WJSC. (1) Classification: Grade C. (2) Summary of the peer-review report: The review article is informative and would be useful to investigators pursuing studies on cancer. However, it is not clear how inhibition of glycolysis or glucose deprivation lead to the death of non-CSCs. The authors need to expand on this issue. Although the current review article provides considerable</p>	[Y]

information about energy metabolism by CSCs and non-CSCs, the authors failed to interpret the data. Lastly, the authors need to add a section on "Future Direction". (3) Format: 1 figure. 132 references were cited, including 31 references published in the last three years. No self-citation. 2 Language evaluation: Grade B. Language editing certificate by AJE was provided. 3 Academic norms and rules: The conflict-of-interest disclosure form and Copyright License Agreement were provided. No academic misconduct was found in the CrossCheck search and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Supported by the National Natural Science Foundation of China, No. 81502564, No. 81972598; the Natural Science Foundation of Zhejiang Province, No. LY19H160004. (3) Corresponding author has published 1 article in WJGO. 5 Issues raised: (1) Please write the "article highlights" section at the end of the main text; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance(Xiao-Quan Yu)
