	<p>mesenteric ischemia due to superior mesenteric venous thrombosis. The patients included in the study came from two distinct hospitals (multicenter study) and their number was considerable. The discussion section gave emphasis to the new contribution of the study in its field. However, there are some issues should be addressed. The authors need add some details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 15 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A, Grade A and Grade A. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the STROBE form. The authors need to provide original Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the Wuhan Tongji Hospital and Wuhan Science and Technology Bureau. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
