2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of exosomes derived from stem cells as an emerging tool for treating intervertebral disc degeneration. The topic is within the scope of the WJSC. (1) Classification: Grade C and D; (2) Summary of the Peer-Review Report: This is a very interesting review about stem-cell derived exosomes. Conclusion may be revised to include</p>	[Y]

the detailed description about the further research needed. Proofreading is needed. The review by Hu et al., starts by presenting intervertebral disc (IVD) degeneration as a common health issue that may be alleviated by exosome-based therapy. The remaining follows by introducing basic features of exosomes and their cargo to follow with evidence of their therapeutic potential on different scenarios. The title should be adjusted to present exosomes as therapeutic entities rather than tools. Although the value of the information gathered is appreciated, it seems that the authors fail to clearly communicate the level of evidence available for the information provided. For example, it is not properly indicated whether the cited results come from animal experimentation or from human clinical trials. In either case, the number of individuals studied (N of the study) may also help readers understand if the data comes from pilot preliminary results or more statistically robust assays. Perhaps this information could be added to Table 2. A critical review of the markers assayed by each study mentioned, in order to claim exosome rather than extracellular vesicle function would improve the quality of the review. (3) Format: There are 2 tables. A total of 81 references are cited, including 54 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic

	<p>misconduct was found in the Bing search and the CrossCheck detection. 4 Supplementary comments: This is an invited manuscript. Without financial support. The topic has not previously been published in the WJG. 5 Issues raised: (1) The “author contributions” section is missing, please add this section at the end of the main text. (2) The “core tip” section is missing, please add this section in front of the main text. (3) The information of the corresponding author is missing, please add the name, degree, title, department, institution, street address, e-mail address in front of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions. Before final acceptance, 1) the authors need to revised the language to meet our publishing standard; 2) a second round of peer review is required.</p>
