(1) Classification: Grade A, Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript presents a comprehensive review of acute ankle sprains, from basic anatomy to clinical evaluation and management and follow-up. However, there are some issues should be addressed. The Figures' red title bar with white lettering seems difficult to read. The questions raised by</p>	[Y]

the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 201 references are cited, including 8 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B and Grade B.

3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. Please rephrase these repeated sentences.

4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited
