within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The reviewer thinks this study is well designed and experimental replicates are acceptable. Introduction and discussion are adequate. Figure 1A y-axis 'min/stuck' needs to be rectified to min/stick. This work might interest those in concerned field. (3) Format: There are 6 figures. A total of 47 references are cited, including 16 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Proof-Reading-Service was provided. 3 Academic norms and rules: The authors did not provide the Institutional Animal Care and Use Committee Approval Form. The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and the ARRIVE Guidelines. The authors signed the Copyright License Agreement and the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was without financial support. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance.
