The topic is in the scope of WJO. (1) Classification: Grade B. (2) Summary of the peer-review report: This is a well-written manuscript dealing with the role of the Ilizarov non-free bone plasty, together with merits and problems of the methods used ofr</p>	[Y]

nonunion and bone defect management of Ilizarow method, Induced menmbrane technique and free vascularized graft. I have just a few comments, mainly on abbreviation. Abbreviations such as PMMA in Discussion and LLD in Tables should be spelled-out. In lines 16 and 22 on page 12, there are blank brackets. Also please check reference 78, URL with underline. (3) Format: 5 tables. 82 references were cited, including 53 references published in the last three years. No self-citation. 2 Language evaluation: Grade B. Language editing certificate was not provided, please upload language certificate of language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure and the Copyright License Agreement were provided. No academic misconduct was found in the CrossCheck search and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG. 5 Issues raised: None. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
