C ; (2) Summary of the Peer-Review Report: The article is good in grammar and scientific writing rules. The topic is actual and well described. In this manuscript, the author reviewed the less common neoplastic lesions of the oesophagus, including rare primary oesophageal benign tumours, rare primitive oesophageal malignant tumours of epithelial and non-epithelial origin, and further rare oesophageal primitive malignant neoplasms. The grammar is impeccable with only a few minor corrections needed. Long and complex sentences should be simplified. (3) Format: There is 1 table and 1 figure. A total of 163 references are cited, including 22 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A, Grade B, and Grade C. A language editing was performed by two senior authors. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by University of Padua. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not
