This article is about management of Budd-Chiari syndrome with restenosis, within the scope of WJG. Summary of peer-review report: Budd-Chiari syndrome (BCS) is associated with a higher incidence in Chinese patients compared to Western countries. Moreover, besides the differences in epidemiological features, the etiology, type of obstruction, and therapeutic solutions</p>	[Y]

are also different in Western vs. This original paper approaches a very interesting issue, and is extremely valuable due to the very long follow-up period of these patients that helps us build a clear overview about the outcome of the BCS patients developing restenosis after recanalization intervention. 2 tables and 3 figures. 26 references were cited, including 9 latest references from 2017-2020. 3 self-citation articles. 2 Language quality: 4B. Edited by AJE language editing services. 3 Academic norms and rules: Retrospective Cohort Study. Copyright license agreement, signed informed consent, IRB, BRC and Conflict-of-Interest statement files are complete and qualified. STROBE statement file is not qualified. Bing search is eligible. CrossCheck: The highest single-source similarity index is 9%. The authors should revise the repeated parts.

The reviewers stated that this manuscript approaches a very interesting issue, and is extremely valuable due to the very long follow-up period of these patients that helps us build a clear overview about the outcome of the BCS patients developing restenosis after recanalization intervention.
