(3) Format: Two figures. Eight references were cited, including one reference published in the last three years. No self-citation. 2 Language evaluation: A and B. Language editing certificate was provided by MedE Editing Service. 3 Academic norms and rules: The authors provided CARE Checklist-2016. The authors signed the conflict-of-interest disclosure form. The authors should sign their signature in copyright license agreement. The written informed consent was provided. No academic misconduct was found in the Bing search. The CrossCheck investigation: The similarity index between this manuscript and the published ones is too high, which doesn't meet the publishing requirements. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJCC.

Reviewer #03011567 thinks that the paper is reasonably well written but requires a number of language corrections; and suggests the authors to review the TTE images to see whether there was any evidence of apical ballooning and hypokinesia with preserved basal myocardial contractility; #00227359 suggests the authors to refresh the follow-up data. 2.
