| | 6c | Relevant history including past interventions and outcomes | <u>6-7</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>6-7</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>6-7</u> |
| | 8b | Diagnostic reasoning including other diagnoses considered and challenges | <u>6-7</u> |
| | 8c | Consider tables or figures linking assessment, diagnoses and interventions | <u>6-7</u> |
| | 8d | Prognostic characteristics where applicable | <u> </u> |
| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>6-7</u> |
| | 9b | Intervention administration such as dosage, frequency and duration | <u>6-7</u> |
| | 9c | Note changes in intervention with explanation | <u> </u> |
