for the treatment of femoral head osteonecrosis. The result seems to be excellent and a careful patient selection should be applied. The results are interesting and useful for physicians involved with such problems. (3) Format: There is 1 table. A total of 30 references are cited, including 4 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A. Three of the authors are native speakers of English. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the Institutional Review Board Approval Form. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. The Biostatistics Review Certificate was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the merit grant from the Department of Veterans Affairs and the Veterans Administration Medical Center in Memphis, the University of Tennessee Health Science Center, and the first hospital of Qiqihar city. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-review: Not required. 7
