The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The reviewer thinks it is a well written and topical manuscript. 	<p>article and will attract good readership. (3) Format: There are 5 figures and 3 tables. A total of 25 references are cited, including 6 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by DUFF was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Signed Informed Consent Form and the Institutional Review Board Approval Form. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. The authors did not provide the pages or lines in the STROBE Statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Natural Science Foundation of Hubei Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
