was not provided. 3 Academic norms and rules: The conflict-of-interest disclosure form was not properly provided and Copyright License Agreement was provided. No academic misconduct was found in the Bing search and the similar index is 32% in the CrossCheck search, the repeated sentences should be rephrased. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published article in BPG. 5 Issues raised: (1) Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. (2) Please add "author contributions" section in front of the main text. (3) Please add "core tip" section in front of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.
