Medicine and Regenerative Orthopedic Surgery. The overall work is well-designed and presented. The other issues mentioned by the reviewer#00646357 should be revised carefully. (3) Format: 4 tables. 117 references were cited, including 18 references published in the last three years. No self-citation. 2 Language evaluation: Grade A and B. Language editing certificate by editage was provided. 3 Academic norms and rules: The conflict-of-interest disclosure the Copyright License Agreement were not properly provided. No academic misconduct was found in the CrossCheck search and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (3) Corresponding author has published 1 article in BPG. 5 Issues raised: (1) The "Author Contributions" section is missing.
