2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the rat hepatocyte organoid formed by co-cultured with mesenchymal stem cells. The topic is within the scope of the WJSC.</p> <p>(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript quality is good overall, but some problems need to be corrected. The questions raised by the reviewer should also be</p>	[Y]

answered; and (3) Format: There is 1 table and 3 figures. A total of 27 references are cited, including 8 references published in the last 3 years. There is 1 self-citation. The corresponding author had published 1 article in BPG. 2 Language evaluation: Classification: Grade A. The language editing certificate was provided by the editage. However, the reviewer pointed out that there was some English spelling and grammatical errors in the manuscript. So the authors need to check across the language again. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, The ARRIVE Guidelines and Copyright License Agreement, and Institutional Animal Care and Use Committee Approval Form or Document. The Institutional Review Board Approval Form is not right, which is not needed. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 4 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of
