2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the impact of cardiologist intervention on guideline-directed use of statin therapy. The topic is within the scope of the WJC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors examined the impact of cardiologist intervention (compared to a general internist) on statin</p>	[Y]

therapy in an outpatient setting, and they found that more patients seeing a cardiologist were prescribed a statin but appropriate intensity of the prescribed statin did not differ between groups. However, some questions raised by the reviewer need to be answered; and (3) Format: There are 2 tables. A total of 15 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors are from United States. However, the reviewer stated that the language needs to be clarified throughout the manuscript. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the Institutional Review Board Approval Form. The Conflict-of-Interest Disclosure Form and STROBE Statement are not qualified. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
