<b>2</b>	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a case report of the Müller Weiss Disease. The topic is within the scope of the WJO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The reviewer suggested to give history, final diagnosis and treatment, and recommended to mention the follow up of patients and the resolution of the pain and disability. Otherwise, the introduction section should be put before the case reports; and (3) Format: There are 2 tables and 5 figures, but the</p>	[Y]

reviewer pointed out that the X-ray/CT scan and the MRI images should be provided for each case. A total of 23 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The author provided himself international English language testing report. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The Conflict-of-Interest Disclosure Form is not qualified. The Written informed consent was not provided. No academic misconduct was found in the Bing search. However, the CrossCheck detection showed a high similarity to published articles (total 6% in the first part and 5% in the second part). The authors need to rephrase the repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The “title, running title, all authors’ information, author contributions, corresponding author’s information, abstract, key words and core tip” sections are missing. Please provide them; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Case Presentation” section was not

	<p>written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor. The type of this manuscript should be Case Report, and the authors need to revise the manuscript according to guideline of "Case Report".</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision. Before final acceptance, the authors need to meet ethics requirement by submitting correct documents.</p>
